



TOMES AUTO GROUP OFFICIAL RULES

Need not to be present to win.

1. ELIGIBILITY: Entrants in the Hugs Cafe Inc Vehicle Raffle (the “Raffle”) must be legal U.S. residents who are at least 18 years of age on or before March 7, 2026, and who are licensed drivers possessing a valid U.S. driver’s license. The Raffle is void outside of the U.S. and where prohibited or restricted by law.
